Please be informed that on a direction of the Parliamentary Business Committee, the following amendments have been made to the circular letter dated 11.03.2016 titled "Procedure to be Followed in Presenting Government Business to Parliament"

Amendments should be made as folowings,

Amendment 1

By removing Section 1.D. in page 2 and replacing it with the following Section.

1.D. Four hundred (400) copies, in all three languages, of the Gazette notification of the Bill;

Amendment 2

By removing Section 3.D. in page 4 and replacing it with the following Section.

3. D. Four hundred (400) copies, of the Supplementary Estimate prepared in all three languages as mentioned above;

By removing Section 4.C. in page 5 and replacing it with the following Section.

- 4.C. Four hundred (400) copies of the Gazette Notification that published the Orders/Regulations/Rules;

Amendment 4

By removing Section 5.C. in page 6 falling under the procedure to be followed in presenting any subject pertaining to a matter directly coming under the purview of the President, and replacing it with the following Section.

- 5 C. Four hundred (400) copies of the subject of Government Business should be submitted to the Prime Minister requesting that necessary action be taken to present it to Parliament;

Amendment 5

By removing Section 9.(iii). in page 10 and replacing it with the following Section.

9. (111) Four hundred (400) copies of the Treaty/Agreement prepared in all three (03) languages - i.e. inclusive of fifty (50) copies for the use of the relevant Sectoral Oversight Committee of Parliament.
