Ordinance

1. This Ordinance may be cited as the Institute of Indigenous Medicine (Amendment) Ordinance, No. 02 of 2016 and shall come into force upon its publication in the *Gazette*.

2. The Institute of Indigenous Medicine Ordinance, No. 7 of 1979, published in *Gazette Extraordinary* No. 67/14 of December 21, 1979 as last amended by Ordinance published in *Gazette Extraordinary* No. 909/13 of February 09, 1996 is hereby further amended as follows :

- (1) in paragraph 5 thereof, by the substitution for the word “degrees” in sub-paragraph (d) of that paragraph of the words “postgraduate degrees, degrees” ;
- (2) in paragraph 12 thereof, by the substitution for the word “degrees,” in sub-paragraph (3)(g) of that paragraph of the words “postgraduate degrees, degrees”.
- (3) in paragraph 13 thereof, by the substitution for the words “a Department of study” of the words “Departments of study”

Ordinance

1. This Ordinance may be cited as the Gampaha Wickramarachchi Ayurveda Institute (Amendment) Ordinance, No. 03 of 2016 and shall come into force upon its publication in the *Gazette*.

2. The Gampaha Wickramarachchi Ayurveda Institute Ordinance, No. 01 of 1995, published in *Gazette Extraordinary* No. 862/8 of March 13, 1995 as last amended by Ordinance published in *Gazette Extraordinary* No. 909/13 of February 09, 1996 is hereby further amended as follows :-

- (1) in paragraph 4 thereof, by the substitution for the word “degrees,” in sub-paragraph (e) of that paragraph of the words “postgraduate degree, degrees,” ;
- (2) in paragraph 11 of that ordinance, by the repeal of sub-paragraph (2)(f) thereof, and the substitution therefor of the following :-

“(f) to recommend to the University in consultation with the relevant Departmental Committee or Committees, the postgraduate degrees, degrees, diplomas, certificates and other academic distinctions which shall be awarded in the several branches of Ayurveda and the courses of study and training to be followed, the examinations to be passed, and other conditions to be satisfied by students who wish to qualify for such postgraduate degrees, degrees, diplomas, certificates and other academic distinctions ;” ;
- (3) in paragraph 15 thereof, by the substitution for the word “degrees,” in sub-paragraph (e) of that paragraph of the words “postgraduate degrees, degrees,”.
