<u>Vote on Account – January to April 2020</u> Head No. 214 – University Grants Commission (UGC)

A Vote on Account has been approved by the Parliament on 23rd October 2019 for the uninterrupted continuation of General Services of the government until the Appropriation Bill for the year 2020 is approved by Parliament. It has been published on the web site of Ministry of Finance; www.treasury.gov.lk.

The Vote on Account permits only the expenditure related to continuation of the programmes, projects and subjects which included in the budget estimates 2019. Therefore, during the period when the Vote on Account is in operation, no commitment shall be made towards new recruitments, new supplies and services and new functions and projects.

Accordingly, you are requested to adhere with the instructions given in the Section 05 of the Budget Circular No: 09/2019 dated 31/12/2019 issued by the Ministry of Finance, Economy and Policy Development.

The University wise allocation for January – April 2020 (Vote on Account) is given in Recurrent Grants (Annex -1) and Capital Grants (Annex-II).

The specimen formats for the preparation of budget estimates for Vote on Account are given in Formats I - VI of this circular.

1. Capital Block Grants (CBG)

a) Construction Projects

Universities/HEIs are requested to allocate funds for the on-going construction projects on priority basis and New construction projects should not be commenced during the period of January – April 2020.

b) Other Development Projects

Universities/HEIs are requested to allocate funds for the Rehabilitation and Improvements of Fixed Assets, Acquisition of Fixed Assets, Human Capital Development and Research and Development projects on priority basis and provide sufficient allocations in their budget.

c) Acquisition of Lands and Vehicles

Funds for the purchase of Lands and Vehicles should not be allocated by the allocated CBG. The Universities/HEIs are required to follow the existing circular provisions for the procurement of Lands and vehicles.

d) Postgraduate/Doctoral programs

Postgraduate/Doctoral programs of university's staff are financed by the UGC/NCAS and Universities/HEIs may not allocate funds from their CBG for this purpose.

2. Continuation of Budget Proposal 2016-2018

UGC allocate funds only for the continuation of the projects implemented by budget proposals 2016-2018. Release of funds during January - April will be considered by the UGC based on the performance of respective projects.

- a) Establishment of Technology Faculties in Universities Rs.875 Mn.
- b) Establishment of Faculty of Medicine Wayamba University of Sri Lanka Rs.225Mn.
- c) Encourage accreditation with professional bodies of international repute -Rs.5 Mn.
- d) Support the University of Colombo for new initiatives undertaken by the Department of Statistics Rs.50 Mn.

- e) Strengthening state of the art library facility and an IT Centre at the Vavuniya Campus Rs.50 Mn.
- f) Accommodation Facilities to Faculty Staff of the Universities Rs. 15 Mn.

New projects will not be financed by the UGC under the allocation referred in No.02 (a) to (f) as given above.

3. Asian Development Bank Funded Projects

The Technology Faculties of Rajarata University of Sri Lanka, Sabaragamuwa University of Sri Lanka and University of Kelaniya and Engineering Faculty of the University of Sri Jayewardenepura are proposed to finance by the Asian Development Bank. The respective universities are advised to communicate with the Secretary, Ministry of Higher Education, and Technology & Innovation through UGC in respect of the implementation of projects.

4. Recurrent Expenditure Block Grant (RBG)

Recurrent Expenditure Block Grants for January – April 2020 has been allocated by the National Budget Department based on the estimates submitted by the Universities/HEIs.

5. Funding for Student Bursaries and Mahapola - Treasury Contribution

Payment of student Bursaries and Mahapola Scholarships shall be made as per the instruction given in the Commission Circular No. 02/2019 and 03/2019.

6. Funds for Postgraduate Institutes

Postgraduate Institutes are advised to finance their budget by the generated income. Capital funds are allocated based on Medium Term Programme recommended by the Capital Projects Monitoring Committee and approved by the UGC.

RBG for the Postgraduate Institute are considered and allocated only to finance their permanent cadre positions as approved by the UGC.

7. General Guidelines

a) In terms of section 8 (2) (b) of the Finance Act. No. 38 of 1971 the approval of the Hon Minister in charge of the subject of finance and the concurrence of the Line Minister should be obtained before incurring capital expenditure in excess of Rs.500,000/-. Therefore Universities/HEIs are requested to submit their capital expenditure program with the Budget to the UGC in order to obtain approval of the Hon. Minister of Finance in this regard.

- b) Please e-mail the <u>soft copy of the Budget prepared as per Format I to VI</u> to <u>budget@ugc.ac.lk</u> on or before 08th January 2020.
- c) You are requested to submit hard copy of the budget on or before 08th January 2020 with a copy to the Director General, Department of National Budget, General Treasury.
- d) Do not change the standard formats by the Universities/HEIs for whatever reason.
