## SCHEME OF RECRUITMENT FOR THE POST OF WORKS ENGINEER (CIVIL)

Your attention is invited to the Scheme of Recruitment for the post of Works Engineer (Civil) laid down in Commission Circulars No. 922 of 23.06.2010, 948 of 10.03.2011 and 10/2015 of 03.09.2015.

- 2. The Commission having noted that certain issues encountered in recognition of qualifications of the existing Scheme of Recruitment for the post of Works Engineer (Civil), and following several deliberations made on the same, decided to amend the Scheme of Recruitment for the post of Works Engineer (Civil) incorporating the requirement of recognition of qualifications at the Institution of Engineers Sri Lanka (IESL) and registration at the Engineering Council of Sri Lanka (ECSL).
- 3. Furthermore, it was decided to include the Bachelor of Engineering Technology (BET) degree specializing in Civil Engineering Technology or Construction Technology to the Scheme of Recruitment for the post of Works Engineer (Civil) as appropriate.
- 4. Having perused the existing qualifications of the Scheme of Recruitment for the post of Works Engineer (Civil) Grade I, the Commission further decided to amend the same including two categories of qualifications.
- 5. Considering the above facts, the Commission at its  $1057^{th}$  and  $1061^{st}$  meetings held on 17.06.2021 and 20.08.2021 respectively, decided to amend the qualifications and experience of the Scheme of Recruitment of the post of Works Engineer (Civil) as shown in **Annex I.**
- 6. The provisions of this Circular will come into effect from 15.09.2021.
- 7. Accordingly, the Scheme of Recruitment referred in the Commission Circulars No. 922 of 23.06.2010, 948 of 10.03.2011 and 10/2015 of 03.09.2015 for the post of Works Engineer Grade III, Grade II and Grade I respectively, will be rescinded with the implementation of this Circular.
- 8. Please take action accordingly.
