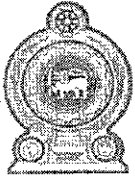


Chairmen of Commercial Corporations, Statutory Boards and Government Owned Companies

Provision of a Monthly Allowance of Rs. 5,000/- to Employees in Commercial Corporations, Statutory Boards and Government Owned Companies

A decision has been taken at the meeting of the Cabinet of Ministers held on 03.01.2022 to provide a monthly allowance of Rs. 5,000/- to state sector employees. With regard to the employees of State Owned Enterprises (SOEs), the implementation arrangement of the said allowance shall be determined by the Board of Directors of SOEs having considered the following:

- I. Eligibility for the allowance:
 - a) Officers who receive a monthly salary serving on permanent/ temporary/ contract basis.
 - b) Officers who are paid a daily wage.
- II. Officers on no pay leave are not entitled to this allowance. The officers on leave with half pay shall be paid fifty percent of the allowance during that time period.
- III. The full allowance should be paid to the employees with daily pay if they have reported for duty on all the days they are required to report for duty and otherwise the allowance should be paid having calculated proportionate to the number of days they have reported for duty.
- IV. The SOEs that have entered into the Collective Agreements shall assess the conditions of such agreements and the financial impact.

This Circular will be effective from 01st January 2022.
