### RESTRICTING THE CALLING OF OFFICERS TO GOVERNMENT CORPORATIONS, STATUTORY BOARDS AND GOVERNMENT OWNED COMPANIES

Your attention is drawn to the Public Enterprises Circular No. PED 03/2022(III) of 23.08.2022 and to Public Enterprises Circular No. PED 03/2022(I) of 14.07.2022 adopted by the Establishments Circular Letter No. 05/2022 of 25.07.2022.

You are kindly requested to adhere to the instructions issued by the Public Enterprises Circular No. PED 03/2022(III) of 23.08.2022 in your respective University and Higher Educational Institute.

Accordingly, the work shift or any other method implemented for calling of staff to Universities and Higher Educational Institutes shall not be operative with effect from 24.08.2022 and all employees of Universities and Higher Educational Institutes should report to work as usual with effect from 24.08.2022. Therefore, normal rules and regulations will be in force regarding the leave from 24.08.2022 onwards.

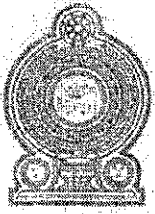
Further, the Universities and Higher Educational Institutes should ensure that their academic activities and other activities are fully functional as usual.
