- 2. Interested bidders may obtain further information from Senior Assistant Secretary / General Administration, University Grants Commission, No. 20, Ward Place, Colombo 07 (Phone 011-2685183) and inspect the vehicle at the premises of the University Grants Commission from 30th June 2025 to 14th July 2025 between 9.00 a.m. to 3.00 p.m. on working days.
- 3. A set of bidding documents could be purchased by interested bidders from 30th June 2025 to 14th July 2025 between 9.00 a.m. and 3.00 p.m. on working days on submission of a written request to the Senior Assistant Secretary/General Administration, University Grants Commission and upon the payment of a non-refundable fee of Rs. 3,500.00 (Rupees Three Thousand Five Hundred). The payment should be made in cash to the Shroff/ UGC.
- 4. A bid should be accompanied with a refundable bid security of Rs. 75,000.00 (Rupees Seventy Five Thousand), obtained from a recognized commercial bank operating in Sri Lanka which is approved by Central Bank of Sri Lanka, which is to be valid for a period of 90 days from the date of closing of bids or should be paid in cash to the Shroff/ UGC, and the receipt of the non-refundable deposit Rs. 3500.00 as in (3) above.
- 5. Duly filled bidding documents with a duplicate, marked "Original" and "Duplicate" in two separate sealed envelopes, both envelopes enclosed in a bigger envelope, marked "Sale of 01 no. of used Vehicle 2025" on the top left hand corner of the envelope should either be sent by Registered Post to the address given below, or deposited in the Tender Box kept at the General Administration Division of the University Grants Commission, No. 20, Ward Place, Colombo 07, to be received before 3.00 p.m. on 14th July 2025. Late bids will be rejected.
- 6. Bids will be opened on 14th July 2025 at 3.00 p.m. immediately after closing of bids at the New Board Room of the University Grants Commission in the presence of the bidders, or their representatives at the address given below. University Grants Commission will not be made liable or responsible for any delay, or misplacement occurs in the post or otherwise, with regard to bids.
- 7. After the declaration of the acceptance of the bid is made, the successful bidder should pay the bid price within 03 days and remove the vehicle within 07 days of the date of the awarding date. The payment should be made in cash only.
- 8. If the selected bidder does not pay the due amount on or before the stipulated date, his bid will be rejected and the bid will be awarded to the next highest bidder.
- 9. If the bid is rejected according to Section 8 of Invitation for Bids, Bid security of such bidder will be forfeited by the University Grants Commission.
- 10. The Bid shall be valid until 30th October 2025.
- Bid submitted in contrary to the advice/ instructions and conditions given here will be rejected.
