THE UNIVERSITIES ACT, No. 16 OF 1978

ORDINANCE made by the University Grants Commission under Section 18 of the Universities Act, No. 16 of 1978.

Ordinance

1. This Ordinance may be cited as the Institute of Human Resource Advancement (Amendment) Ordinance, No. 03 of 2017 and shall come into force upon publication in the *Gazette*.

2. The Institute of Human Resource Advancement Ordinance, No. 11 of 1979, published in the *Gazette Extraordinary* No. 68/10 of December 26, 1979 as last amended by Ordinance published in *Gazette Extraordinary* No. 1450/23 of June 22, 2006 is hereby further amended as follows :-

(1) In Paragraph 6 thereof –

(i) By the repeal of items (c) and (d) thereof, and the substitution therefore of the following :-

" (c) To determine with the approval of the University and the concurrence of the Commission, the degrees, diplomas, certificates and other academic distinctions to be awarded in the approved branches of learning ;



(d) to conduct with the approval of the University, examinations for the purpose of ascertaining the persons who have acquired proficiency in the approved branches of learning and to recommend to the University persons, who, having passed such examinations and having satisfied such other conditions as the University may prescribe by By-laws in consultation with the Institute, are eligible for the award of degrees, diplomas, certificates and other academic distinctions of the University;" ;

(2) in Paragraph 13 thereof –

(i) by the repeal of item (c) of subparagraph (2) thereof, and the substitution therefore of the following :–

“to recommend to the University, in consultation with the Board or Boards of Study concerned, the degrees, diplomas, certificates and other academic distinctions which shall be awarded in the approved branches of learning and the courses of study and training to be followed, the examinations to be passed and the other conditions to be satisfied by students who wish to qualify for such degrees, diplomas, certificates and other academic distinctions;”;

(3) in Paragraph 17 thereof –

(i) by the repeal of items (g) of subparagraph (2) thereof, and the substitution therefore of the following :–

“To recommend to the Syndicate persons, who, having passed the prescribed examinations in that branch of learning and having satisfied other prescribed conditions, are eligible for the award of degrees, diplomas, certificates and other academic distinctions in that branch;”.
